Dear Eagle Bluff supporters,

Looking back, 2022 proved to be a year of rebuilding for Eagle Bluff given the COVID-19 pandemic still presented significant challenges for schools and groups to visit us. Despite these challenges, Eagle Bluff remained steadfast in our commitment to host groups so that we could provide outdoor experiences that connect people with each other and the natural world. **We welcomed back 57 more schools and 48 more day use and retreat groups than we hosted in 2021** – some of which hadn't been onsite for two years!

We've also been focused on caring for our campus land and buildings and enhancing our programs. Highlights include:

- Putting 130 acres of "The Point" property into a permanent conservation easement with the Minnesota Land Trust so the property will be protected from development in perpetuity.
- New roofs for the dining hall and dormitory.
- Rebuilding the East high ropes course which now contains two zip lines and 18 elements to traverse.
- Upgrading the personal safety equipment on all three of our high ropes courses.
- Purchasing new snowshoes and other outdoor winter gear.



These projects, as well as our continued commitment to empower people to care for the earth and each other, would not be possible without your generous support.
